

Move Back to Westfund Terms and Conditions – eGift card Offer:

- This offer is only available for members who have cancelled their membership with Westfund in the last two to thirteen months (cancellation date from 20 April 2023 to 19 March 2024) to move to another private health insurer and have rejoined on any combined hospital and extras cover and has a start date between (and inclusive of) 20 May 2024 and 16 June 2024. This offer is not available for rejoins on Ambulance Only, Extras Only, Hospital Only, Corporate Groups or Overseas products.
- 2. Re-joins on an eligible level of cover for single memberships will be sent a \$150 after serving a 90-day review period, provided they have maintained an eligible level of cover and are up to date with payment.
- 3. Re-joins on an eligible level of cover for couple or family memberships will be sent a \$300 eGift Card after serving a 90-day review period, provided they have maintained an eligible level of cover and are up to date with payment.
